

ESG - For or Against?

ESG Concensus Score Approach

The **ESG Portfolio Monitor** leverages sophisticated artificial intelligence and machine learning to consume ESG data from multiple rating vendors and other sources. Robust statistical analysis normalizes and weights those data inputs to generate 'consensus ESG ratings.' This minimizes the inherent subjectivity associated with the use of any single ESG rating firm.

Also, the consumption of such large amounts of data enables significantly greater coverage, and facilities more frequent rating updates.
